Individualized Education Plan (IEP)



LEWELS OF SUPPORT



Plan set in place to ensure staff is aware of and can address intermittent or emergency health needs while in the school setting Examples: Food Allergy, Bee Allergy, Asthma, etc.

REQUIREMENTS: Doctor's note(s)

DOES: Make team aware of medical needs and minor accommodations to adjustments to meet health needs



LEWELS OF SUPPORT

504 Plan

Plan set in place per ADA law for persons with disabilities to ensure equal access and accommodations to participate in the educational environment.

Examples: Strategic/Flexible/Alternative Seating, Field Trips, Group Activities, PE,

Parent/Staff/Teacher Communication

REQUIREMENTS: Proof of Disability and/or assessment and/or doctor's note(s)

CAN: Be combined with a Health Plan

DOES: Provide accommodations specific to areas of the educational setting (class, campus, PE, Field Trips, materials, supplies, equipment)



LEWELS OF SUPPORT

Individualized Education Plan (IEP)

Educational plan set in place for students who require supports AND services to access and make progress in the educational setting that cannot be met with the above listed supports.


REQUIREMENTS: Assessment by Special Education Team and Determined to be Eligible under one of the Categories of Eligibility per IDEA

CAN: Be combined with a Health Plan, be requested, come after the above have been attempted


DOES: Provide accommodations AND services specific to areas of need (academics, health, physical and/or occupational therapy or other specialists)

LEVIL OF SUPPORT

Plan set in place per ADA law for persons with disabilities to ensure equal access and accommodations to participate in the educational environment.
